agreement contract **Information**

This is a contract agreement between the legal owner or handler of the dog (hereafter "the Guardian") where signature appears below and LE SALON ET SPA POOCHIE GLAM (hereafter "Poochie Glam").

- A. The Guardian agrees to pay the rate of services rendered by Poochie Glam when due and acknowledge that all payments are due when services or products are rendered. No refund options on pre-paid daycare packages.
- B. The Guardian agrees to pay all services rendered according to current price list as determined by Poochie Glam; the Guardian further agrees to pay for all requested and necessary services, and all veterinarian costs incurred by the Dog during their stay with Poochie Glam. Late charges will be charged accordingly in addition to the services rendered.
- C. The Guardian agrees that the Dog shall not leave the Poochie Glam premises until all charges are paid to Poochie Glam by the Guardian in full without exception.
- D. Poochie Glam agrees to ensure responsible due diligence and proper action in keeping the premises sanitary and properly structured. Should the Dog become sick or require immediate medical attention, Poochie Glam reserves the right to administer any needed aid and/or to contact any available veterinarian at the sole expense of the Guardian.
- E. The Guardian must provide proof of current vaccination records for the Dog. The following vaccines are mandatory: Parvo virus, rabies, distemper and Bordetella (DHLPP + rabies). The required information must be provided before the Dog can have access to the Poochie Glam daycare. Poochie Glam reserves the right to refuse service upon failure to present current vaccination records.
- F. The Guardian agrees that during a visit at Poochie Glam the Guest is at health risk if failure to have a current vaccination record with the following vaccines: Parvo virus, rabies, distemper and Bordetella (DHLPP + rabies).
- G. The Guardian agrees that the Dog must be spayed or neutered to participate in any daycare services.
- H. The Guardian confirms that the Dog is in good health and has not had any illness or communicable disease in the past 30 days; the Guardian further confirms that the Dog has not harmed or shown aggression towards any person or any other pet.
- I. Poochie Glam, at its sole discretion, reserves the right to refuse or terminate services for the Dog at any time and, if applicable, at the sole expense of the Guardian.
- J. The Guardian agrees that the Dog will be picked up by the Guardian or any emergency contact identified in this Registration Form.
- K. The Guardian acknowledges and agrees that the dog must be picked up at the time agreed upon between the Guardian and Poochie Glam. Late fees will apply should the Dog remain at the Poochie Glam premises beyond the agreed upon time.
- L. The Guardian agrees that Poochie Glam has the right to remit the Dog to a third party organization dedicated to the protection and care of animals in the event that the Guardian does not return to pick up the Dog by end of business day in which services were rendered. It is the sole responsibility of the Guardian to be aware of Poochie Glam's daily business hours. All expenses incurred by Poochie Glam in such circumstances will be the sole responsibility of the Guardian. Poochie Glam will attempt to contact the Guardian and any emergency contacts provided in this Registration Form prior to remitting the Dog to any third party.
- M. The Guardian agrees that the Dog may be photographed or recorded. Poochie Glam shall be the exclusive owner of the results and all proceeds of such photography, tapings and recordings with the rights, throughout the world, an unlimited number of times in perpetuity, to copyright, to use and to license to others in any manner. The Guardian further agrees that the Dog may be used without any monetary compensation to same in any and all media and in promotion, advertizing, sale, publicizing, and exploitation of Poochie Glam.
- N. By signing this agreement and leaving the Dog with Poochie Glam, the Guardian acknowledges the accuracy of all information provided in this Registration Form.
- O. This agreement contains the entire agreement between the parties, all terms and conditions of this agreement shall be binding on the heirs, administrators, personal representatives and assigns of the Guardian and Poochie Glam.
- P. The Guardian also acknowledges that Poochie Glam has provided all information in a structured scheduled manner to allow him or her a sufficient time period to ensure they understand and accept all the terms and conditions of the contract before signing it.
- Q. The parties agree that this contract be drawn up in English. Les parties confirment que le contrat soit rédigé en anglais.
- R. By signing below the Guardian assumes full responsibility for the Dog, as well as any incident related to physical injury and/or material damage caused to the surroundings, personnel or other dogs at Poochie Glam. The Guardian releases Poochie Glam and any of its directors or employees from any liability of any nature resulting from the actions or behaviors of the Dog.
